2. Treasurer's Report:

- Legal actions: Paper work submitted to court to try to garnish his wages for the back dues that due.
- Still have several who have not paid dues. The late date is February 16th. Some dues which are rental properties have paid only the \$400.00 dues instead of the \$425.00 that is due. Still trying to work out the bugs in the new Town Square financial system being used by Neighborhood Services.

3. Old Business:

- Update on the Shade Structures:
 - Kristi has sent numerous emails and Dale Srnka has left many voice mails. So far, they have not been responding to emails or phone calls. Dale went to their office on December 11th, 2020. All conversations and emails have been unsuccessful.
 - o Lawyer involvement, small claims, etc.
 - Work with a lawyer to get a demand letter written.
 - We will need to find out how to deliver the letter.
 - The Board discussed New permitting will be required with new contractor and plans

Box Frame w/Shade Sail: 3 – 23'x14. \$22,770 ACS Playground Adventures – Not yet received Recreation Resource USA – Not yet received

Noah's Playground - Not yet received.

Don recommended we just get a shade structure from Sam's and bolt it to the concrete and get out 10 years out of it, and then replace it again. They are \$1,500.00 each. Don't need a permit and hard to justify in excess of \$30,000.00 for the shade that is used only a few months a year.

Bottom line, the board decided to seek legal action and try to recoup the \$9,000.00 from the company. Next alternative would be to consider small claims court. Once those are tried, if they fail we will consider going to the media.

- Brick wall repairs. Mario will draft some Terms and Conditions for review by the board. Mario has checked with several references and all checked out. Contract now at \$14,900.00 Mario has a letter that the City does not require a permit to repair or rebuild the wall. Board decided to move quickly to get the job completed.
- Nancy has asked Urban Logging to get back on our project now the storm debris has been cleaned up. He agreed to start the work in two weeks after this cold snap is over.

4. New Business:

- Options for UCO Volunteers on Saturday, March 27th
 - Do we have projects for them to work on? Might have them dig some holes for the new trees. Always have some trash to clean up in the green belt, and flower beds to weed out, paint the shed in the pool area.
- Set the day for Neighborhood Clean-up.
 - Try to coordinate with getting the pool cleaned up and ready to go. Board decided to go for May 22nd.
- Set date for Spring Neighborhood Garage Sale.
 - o Board decided on April 23rd 24th.
- Options for annual neighborhood meeting.
 - Nancy checked with Santa Fe Prsbyterian Church about using the building for our annual meeting. The building indicated that a Thursday or Friday night would be acceptable and we would not have to worry about cleaning up. Thursday, March 11th was selected for the annual meeting date. Kristi will also explore options to have a virtual meeting at the same time.
